Title: SCHEDULE OF FEES AND TOLLS FOR THE RICKENBACKER CAUSEWAY

Ordered: 9/18/2025

Effective: 10/1/2025

AUTHORITY:

The Miami-Dade County Home Rule Amendment and Charter, including among others, Sections 1.01 and 2.02A and Section 125.01(1)(m) of the Florida Statutes.

SUPERSEDES:

This Implementing Order supersedes Implementing Order No. 4-57, ordered on September 28, 2017 and effective October 9, 2017.

POLICY:

This Implementing Order establishes the schedule of fees for Per Trip SunPass Tolls, Toll-by-Plate per Trip Tolls, Toll-by-Plate Monthly Invoice Fees, Commuter Plan Fees, and Resident Plan Fees.

PROCEDURE:

The administration of this Implementing Order is designated to the Director, Miami- Dade County Department of Transportation and Public Works or successor department, who shall be responsible for the collection of tolls and fees, and the maintenance and operation of the Causeway. The Director shall periodically review all fees in terms of the Causeway's maintenance and operational costs, other financial obligations, and capital improvement needs, as well as recommend changes to the County Mayor through this Implementing Order procedure.

FEE SCHEDULE:

The fee schedules adopted by this Implementing Order are attached hereto and made a part hereof, and are on file with the Clerk of the Board of County Commissioners. Fees charged by the Department of Transportation and Public Works shall be the same as those listed in the official fee schedule on file with the Clerk of the Board of County Commissioners.

This Implementing Order is hereby submitted to the Board of County Commissioners of Miami-Dade County, Florida.

Causeways Plans Valid from October 1 – September 30 of the following year
(unlimited passage)

Commuter Plan Fee

\$120.00/year

(Two (2) axle private vehicle registered to driver employed or attending school on the Rickenbacker Causeway, Virginia Key or Key Biscayne, or two (2) axle commercial vehicle registered to businesses based in Key Biscayne (excludes taxis, dualies and busses.)

Resident Plan Fee

\$72.00/year

(Residential property owners on Key Biscayne, residential property renters/tenants on Key Biscayne (minimum term of six months), spouses and their children 23 years old or younger who live with a parent on Key Biscayne; available for two-axle non-commercial vehicles only).
