Through Miami-Dade County's Department of Cultural Affairs, Art in Public Places program, 1.5% of the cost of construction on public land is dedicated to the commissioning of public art. This request for qualifications is for professional artists to commission public art. The selected artist(s) will design unique artwork(s) that will contribute to the identity of this facility and engage employees, visitors and passers-by in unexpected and delightful ways.

Overview

It is envisioned that the artist selection process for these two projects, Courtside Apartments II and Rainbow Village I will occur in parallel, and that artists will submit qualifications for consideration of a shortlist of artists that will be invited to prepare full proposals for one or both projects. Both projects are being developed by Housing Trust Group (HTG) on behalf of the Miami-Dade County Department of Public Housing and Community Development.

Courtside Apartments, Phase II:



Courtside Apartments Phase II is a 120-unit new-construction multifamily development designated for families located in the City of Miami, Miami-Dade County, Florida among an existing campus of buildings at the Courtside Apartments development. **Courtside Apartments Phase I** consists of two 5-story mid-rise concrete buildings, cladding for existing parking garage, and graded parking. The North Building consists of 82 units and is located at the SW corner of NW 17th Street and NW 3rd Avenue. The South Building consists of 38 units 500 ft south of the SE corner of NW 17th Street and NW 4th Ave.





Opportunities for Public Art

North Parking Area Wall

- Application to exterior CMU block wall, approximately 200 W x 5 H feet.
- Applied artwork that will be highly visible from graded parking lot as residents park and enter the facility

Campus:

- Site-specific artworks or free-standing sculpture designed to enhance the existing campus and existing network off walking paths and green areas between buildings
- Exterior application to large-scale façade of existing structure, adjacent to garage in South build.

Garage Façade

• Artworks applied to stucco on the façade of the existing garage.

Interiors and Lobby Experience

Two-dimensional artworks to activate the facility's lobby and common areas, including but not limited to site-specific
installations, durable applications and applied artworks.

Rainbow Village - Phase I



Rainbow Village is a campus of four individual buildings. These "live – work" units on the Overtown and Wynwood border are envisioned to be constructed over four phases, with the first a 7-story 310-unit new construction development with one concrete block building. For this development, **Rainbow Village I**, Housing Trust Group will be partnering with Miami-Dade Public Housing and Community Development to redevelop an existing public housing development built in 1972. The property will feature a top-tier market-quality amenity package designed by award-winning architecture firm Zyscovich. Amenities will include a resort-style pool and a sundeck with cabanas.

It is envisioned that artists will approach the commission opportunities to pay homage to the history and rich cultural heritage of Miami's Overtown neighborhood since the 1970's.





Opportunities for Public Art



Interiors and Lobby Experience

• Two-dimensional artworks to activate the lobby of Rainbow Village and common areas, including but not limited to site-specific installations, durable applications and applied artworks.



Pool Deck / Open Air Courtyards

- Stand-alone sculpture or site-specific artworks in durable materials for the pool deck area, including but not limited to seating and shading structures, sculpture, or durable applications to exterior walls.
- Artworks to active two (2) open-air courtyards within the building, one is planned to accommodate a larger children's playground. Both can be viewed from above.







Paseo

- Artist designed seating, sand-alone sculpture (perimeter) light-based artworks, south- west plaza (as seen above).
- Pattern for hardscape and plazas wayfinding artist designed hardscape. It is envisioned that a design approach for hardscape may allow all phases to be connected visually throughout the property.

Process

Pursuant to the processes of the Miami-Dade County Art in Public Places Program, a three-member group of art and architectural professionals drawn from the Professional Advisory Committee (PAC) will recommend a shortlist of artists to create full proposals to the Art in Public Places Trust. The primary criteria for shortlist selection will be previous artistic accomplishment as demonstrated in images of completed artwork, public art experience, and/or initial design approach to the project as demonstrated in the artist's statement. Artists who have not created public art before are warmly invited to apply. If appropriate, the PAC reserves the right to recommend artists who may not have applied to this Call to Artists.

Upon being recommended to prepare full proposals, shortlisted artists will receive detailed information regarding the opportunities for public art. Artists will also be invited to attend a site visit and Artist Orientation meeting, and will have the opportunity to meet with the client, including the design & the construction teams, and Art in Public Places staff.

Shortlisted Artists will receive a proposal honorarium, as well as an allowance for travel-related expenses for personally attending the recommended meetings in Miami-Dade County including the Artist Orientation and final proposal presentation meeting. Artists may choose to present their final proposals via video conference. Art in Public Places staff will be available to support inquiries throughout the process. Upon the presentation of proposals, the PAC will make recommendations for final commissions to the Art in Public Places Trust for their consideration.

Art in Public Places is a program of the Miami-Dade County Department of Cultural Affairs responsible for the commission and purchase of artworks by contemporary artists in all media. One of the first public art programs in the country, Miami-Dade Art in Public Places was established in 1973 with the passage of an ordinance allocating 1.5% of construction cost of new county buildings for the purchase or commission of artworks, educational programs and collection maintenance. The Art Trust Fund is administered by a County Commission-appointed citizens' board, the Art in Public Places Trust, in consultation with its Professional Advisory Committee.
