Through Miami-Dade County's Department of Cultural Affairs, Art in Public Places program, 1.5% of the cost of construction on public land is dedicated to the commissioning of public art. This request for qualifications is for professional artists to commission public art. The selected artist(s) will design unique artwork(s) that will contribute to the identity of this facility and engage employees, visitors and passers-by in unexpected and delightful ways.

Detailed Description

The Miami-Dade County Courthouse, known as "Cielito Lindo", or "beautiful sky", is a historic courthouse located at 73 West Flagler Street in Miami, Florida. It was constructed over four years (1925–28) and was added to the U.S. National Register of Historic Places in1989. The facility will be functionally replaced by the Civil and Probate Courthouse, located adjacent to the historic courthouse. There, operations will take place for the Miami-Dade County Civil and Probate Divisions of the Eleventh Judicial Circuit of Florida, the Clerk of Courts and other related Court Partner, administrative services, court related programs, court support functions and facility management services.

The new Civil and Probate Courthouse, estimated to be completed in early 2025, includes twenty-four (24) floors, forty-six (46) finished jury courtrooms and one (1) additional shell space for an additional four (4) jury courtrooms including fifty-nine (59) secure parking spaces. The courthouse shall be a significant landmark. Its architectural form shall balance expression of the authority and power of the law with a concern for the needs of the people who enter seeking justice. Its articulation shall balance tradition with a progressive spirit to uplift and inspire all those who enter.





A courthouse is one of the most important and symbolic of public buildings. Courthouses represent the government of the people and the ideals of the Florida judicial system: the rule of law, equal justice and the peaceful resolution of disputes. Courthouses give tangible form to the community's respect for law and order. Courthouses also have great significance as a place of public service. Here disputes are resolved, and justice is pursued. It is here that important records are kept and made available for public use. It is here that elected judges and responsible citizens consider together the difficult questions of responsibility and equity. **References:** Wikipedia: https://en.wikipedia.org/wiki/Miami-Dade County Courthouse





Opportunity for Public Art

For the project Homage to Cielito Lindo, it is envisioned that an artist will create an original work of art that commemorates and responds to the design features, architecture, history, aesthetics, community associations and historical narratives of the Miami-Dade County Courthouse, widely known as Cielito Lindo.

The artwork will be located on the 13th floor Ceremonial Courtroom of the new Civil and Probate Courthouse, an area of great significance, and will be installed on a wall with dimensions of approximately 30 feet in width by 10 feet in height. The original work of art is envisioned as a site-specific installation and / or mixed-media collage that draws inspiration from the historical context, community narratives and key events that transpired in and around the historic facility since the 1920's, incorporating elements including but not limited to:

- Historic and contemporary photographs, archival materials and depictions of Cielito Lindo and its interiors and context
- References to design features and architectural elements from Cielito Lindo
- References to related events and historical narratives

The selected artist will:

- Engage with a local historian to identify critical moments of historical significance and community narratives
- Maintain a high level of flexibility in the final design, content, and material execution of the artwork in response to multiple rounds of detailed feedback from the client team
- Be available to engage in the design process, complete and install the artwork on site by <u>January 30, 2025</u>

Additionally, is envisioned that artists shall respond to the design principles of dignity, durability and accessibility. The selected artist shall consider not only physical durability, in terms of performance and maintenance, but also symbolic value, cultural associations, and local significance. This public artwork shall reinforce the image of the courts as an enduring, fundamental institution of our society.

Process

Pursuant to the processes of the Miami-Dade County Art in Public Places Program, a three-member group of art and architectural professionals drawn from the Professional Advisory Committee (PAC) will recommend a shortlist of artists for consideration of the project. This shortlist will be presented to the Art in Public Places Trust for approval.

Shortlisted artists will be invited to engage in an orientation and verbal interviews regarding their proposed project direction and refer to their body of completed past work as a reference. Based on this interview, the PAC will recommend a finalist to pursue the commission. The finalist will be presented for consideration for approval by the Art in Public Places Trust.





The finalist will receive detailed information regarding the opportunity for public art, and will develop their final design in conjunction with the client team, including the design & construction teams, and Art in Public Places staff.
