For a combined total expenditure amount not-to-exceed \$8,000.00 for the Gallery at West Brickell housing development project.

Background

A meeting of the Professional Advisory Committee (PAC) convened on March 21, 2024 to review the credentials of 220 applicants responding to a National Call to Artists for the Gallery at West Brickell, a mixed-use housing projects being developed in partnership between the Miami-Dade Department of Public Housing and Community Development (PHCD) and local developer Related Urban. Located in the Brickell neighborhood at 201 SW 10th Street, Miami FL 33130, the new facility includes 465 apartment units in 29 stories, a stand-alone parking garage with 547 parking spaces and many amenities including flexible workspaces, podcast flex room, conference room, package room, fitness center and a yoga/spinning room, game and media room, clubhouse, dining room, and a rooftop pool with barbecues, as well as a flex lawn.

With a total budget of \$846,000.00, the project offers multiple public art opportunities that include, but are not limited to, light-based artworks, suspended artworks, screening systems, and applications of

two- and three-dimensional artworks or installations for interior spaces, as well as applications of freestanding artworks for the roof-top pool deck. After careful review, deliberation, and input from the client team, the PAC unanimously recommended the following eight (8) artists and three (3) alternates in order of preference to create full proposals:
