Background

A meeting of the Professional Advisory Committee (PAC) convened on July 18, 2024, to review the credentials of 215 applicants responding to a Regional Call to Artists for the new Key Biscayne Branch Library. The project consists of the construction of a 19,000 square feet state-of-the-art LEED certified library at the site of the existing and outdated library building. The public art opportunity at this facility has been identified as a feature wall located behind the customer service desk that connects both the first and second floors. It's envisioned that the selected artist will have an affinity for Biscayne Bay, nature, and the beauty and history of Key Biscayne. After careful deliberation and input from the client teams, the PAC unanimously recommended the following eight (8) artists and two (2) alternates in order of preference to create full proposals:
