## Recommendation

It is recommended that the Art in Public Places Trust approve Artwork Acquisition Agreements in substantially the form attached with the following nine (9) FY 22-23 South Florida Cultural Consortium artists based in Miami-Dade County in the following amounts:

## **Background**

The South Florida Cultural Consortium Grant Program offers one of the largest regional, government-sponsored artists' grants in the United States, awarding \$15,000 and \$7,500 grants to resident visual and media artists from the counties of Broward, Martin, Miami-Dade, Monroe, and Palm Beach. Since it was established in 1988, the Consortium has awarded more than \$4 million in grants to over 300 artists. In addition to receiving the grant, the artists take part in an exhibition hosted and organized by a visual arts institution in one of the five counties. The SFCC is governed by a board made up of the directors of the cultural affairs departments from the five member counties.

Each year, more than 300 artists who live and work throughout the five counties submit their applications for consideration to the South Florida Cultural Consortium's Grant Program for Visual and Media Artists. The recipients are selected through a two-tier panel process which includes the participation of regional and national arts experts. The national panel also recommends whether selected artists receive the fellowship at the \$15,000 level or the \$7,500 level. The national panel's recommendations are reviewed and ratified by the South Florida Cultural Consortium and approved by the Miami-Dade County Board of County Commissioners.

In a continued effort to support regional artists, in 2019 the Artwork Acquisition Program was inaugurated by the Miami-Dade Department of Cultural Affairs to augment the benefits received by Miami-Dade based SFCC grant award recipients. It is the intention that this funding be used to enhance the FY 23-24 Miami-Dade artists' SFCC grant awards by acquiring artworks to accession into the Miami-Dade Art in Public Places Collection. The annual acquisition award is equally divided among all winning artists of the given year.

At the September 26, 2023, meeting of the SFCC, the FY 23-24 SFCC budget was adopted, with Miami-Dade County Department of Cultural Affairs dedicating \$70,000 for the Artwork Acquisition Program. The funding for this program is included in the Department's grants budget and authorized by Miami-Dade County Ordinance No. O-23-81.

Artworks will be selected for accession into the APP collection by the APP Program's Curator & Artist Manager, Amanda Sanfilippo Long, based on her serving as the Director of the SFCC and her familiarity with the artists after managing the entire selection process for this annual grants program. The selected artworks take into account the fair market price for the recommended acquisitions and the current value of the work of each artist. The acquisition amount also covers any expenses needed for the works to be ready to install and delivered to the Art in Public Places offices. The recommended selection of artworks for accession in the APP collection will be subject to the final review and approval by the Trust via a separate accession memo.



APP staff recommends the approval of Trust Resolution APPT No. 24-49 authorizing acquisition contracts with each of the following (9) artists with the respective amounts listed below for each:
