Approval of June 10, 2025, APP Trust Meeting Minutes

Trust Resolution No. APPT 25-36, Mikyoung Kim Studio, LLC – Zoo Miami Entrance and Ripple Garden / Conservation Contract

Trust Resolution APPT No. 25-36 authorizes a Professional Artist Services agreement with Mikyoung Kim Studio, LLC (lead artist Mikyoung Kim) in the not-to-exceed amount of \$30,000.00 for assessment and conservation services of the APP Collection artworks *Ripple Gardens at Jackson South* and *Zoo Miami Entrance at Zoo Miami*.

Trust Resolution No. APPT 25-37, James Brazil at Joseph Caleb Auditorium / Addendum 2

Trust Resolution No. APPT 25-39, Carolina Sardi, PortMiami, Conservation Contract Trust Resolution No. APPT 25-39 authorizes a Professional Artist Services Agreement with Carolina Sardi, Inc. (lead artist Carolina Sardi) in the not-to-exceed amount of \$48,000.00 for conservation services of APP Collection Artwork, *the Journey: Suitcase Project, and Water Project.*

The motion to adopt Trust Resolution No. APPT 25-39 was approved unanimously (Motion by Mr. Sexton, seconded by Mr. Fernandez)

Reports and Discussion Items

Program Updates

2025 Sunset Review of County Boards – Art in Public Places Trust (January 2023 – December 2024)

Amanda Sanfilippo Long, APP Curator and Artist Manager, reported that the Sunset Review of County Boards is an assessment and a requirement for the continued existence of the County boards. This biennial report of the activities and accomplishments of the Art in Public Place Trust is submitted to the Board of County Commissioners as a recommendation to continue or to sunset the Council. The recommendation to approve the Sunset Review report of the Art in Public Places Trust recommending the continuation of the board was approved unanimously. (Motion by Ms. Hernandez, seconded by Ms. Belo-Osagie)

Project Updates

Grove Central at Coconut Grove Metrorail Station

Ana Meza, APP Projects Manager, shared an update on the recently completed project at Grove Central by Miami-Dade-based artist Asser Saint Val. The artist created a sculptural bronze planter inspired by the early Bahamian settlers in Coconut Grove and the fashion of the early 20th century. Situated prominently within the main roundabout of the bus station, the

large-scale bronze bust features landscaped berms, a yellow elder tree sprouting from the figure's head, and an irrigation system to supply water to the plant. The sculpture is visible to bus riders, pedestrians, visitors to The Underline, and Metrorail riders using the Coconut Grove Metrorail station.

Director's Report

Ashlee K. Thomas, Deputy Director, announced that Mayor Danielle Levine Cava has presented a proposed budget for FY 2025-2026 that includes the merger of the Department of Cultural Affairs into the Miami-Dade Public Library System. The new department will be rebranded as "Arts, Culture, and Library Services Department." In addition to the merger, the proposed budget eliminates the position of the Department of Cultural Affairs director position, keeps all currently filled Cultural Affairs positions with classification and compensation, and significantly decreases funding for cultural grants to nonprofits and capital funding for cultural projects. Two budget hearings are scheduled to finalize the County budget, the first will takes place on September 4th, and the second on September 18, 2025.

Trust Member Reports

Dr. Damian inquired about the schedule for the Executive Trust meeting. APP staff will coordinate directly with the Trust to establish a meeting date and time for the month of August.
