Background

A meeting of the Professional Advisory Committee (PAC) convened on April 24, 2025, to review the credentials of one hundred and seventy-eight (178) artists who submitted qualifications from a South Florida Regional Call to Artists to participate in the Artist Registry for public art opportunities related to various Miami-Dade Housing and Community Development projects across the County. In response to an influx of new public-private housing developments with fast-track completion schedules, the Art in Public Places program sought to create a broader shortlist of local-based artists who would be grouped in smaller shortlists and invited to develop proposals for specific housing initiatives, including affordable, workforce, and elderly housing with differing construction timelines. On May 13, 2025, the Art in Public Places Trust approved the PAC recommended Artists Housing Registry shortlist of 31 artists who would be eligible for up to (1) year from this approval to participate in various project-specific proposal development opportunities.

Per this initiative, APP staff is prioritizing a shortlist of eight (8) regional artists to develop proposals for the new garage of the Caribbean Isles development project, a public- partnership between the Miami-Dade Department of Housing and Community Development and Pinnacle Communities. This development is being built in two separate phases with the garage portion being prioritized to include approximate 231 spaces of which 150 parking stalls are dedicated to Miami-Dade Transit for its park and ride program along the South Corridor busway. The balance of parking spaces will be dedicated to the residents of the senior housing portion of the project breaking ground in the later part of 2025. The funding for the garage commission will combine APP funds from the construction of both the residential and garage projects of the development.

The opportunity for public art for the garage includes applications of paint or applied durable materials such as metal or tile work for a grouping of eleven (11) rectangular areas on the façade of the garage. These frieze areas have excellent visibility facing Caribbean Boulevard. It is intended that the artist's budget also cover the artwork lighting. The development team is facilitating as part of the garage construction budget, the running of conduit to various stub up locations for the future installation of electrical service and lighting fixtures.

From the Trust-approved Artists Housing Registry, APP staff recommends that the Trust invite the following eight (8) artists:
