For a combined total expenditure amount not-to-exceed \$25,000.00 for the Integrated Command and Control Center Facade project.

Background

A meeting of the Professional Advisory Committee (PAC) convened on May 29, 2025, to review the credentials of one hundred and sixty-four (164) artists who submitted qualifications from a National Call to Artists for the new Miami-Dade Integrated Command and Control Center façade project. Designed by Gensler and built by Suffolk Construction, the County is implementing a new state-of-the-art emergency complex combining three (3) different buildings including a fortified bunker with 12 stories for government offices, personnel, and emergency services and vehicles, radio tower, and a garage with nine (9) floors of parking. The new facility will provide continuity of government during crisis, a place for the National Weather Service to operate, and permanently house the county's Real Time Crime Center, numerous communication systems and the county's 911 and 311 operators.

The opportunities for public art for this project are being addressed under two (2) separate Call to Artist, with the first National Call prioritizing the exterior opportunity for a building façade treatment and or enhancement that would transform the complex's basic architecture into an iconic structure. Artwork concepts may consider the use of layered and painted metal applications, applied light-based video projection mapping, kinetic artwork, and or interactive media responding to weather or atmospheric conditions of our geographic area. Funds for this specific opportunity are advertised as \$1.25 million.

The facility, nearing design completion, will procure and install a perforated screening system covering three of the four building facades including the North, South, and West elevations, with this last façade being prominently visible from the nearby Florida Turnpike. Shortlist artists will work with APP staff and the project's design and engineering team to develop design concepts that can be integrated in the perforated base material and or potentially enhanced with other three and or two-dimensional elements, finished materials, colors, media, and or lighting.

PAC unanimously recommended the following ten (10) artists to create full proposals for this first phase of the APP collaboration:
