Trust Resolution No. APPT 26-18

RESOLUTION APPROVING A PROFESSIONAL ARTIST SERVICES AGREEMENT IN SUBSTANTIALLY THE FORM ATTACHED WITH JACOUB REYES IN THE FIXED FEE AMOUNT OF \$ 40,000.00 FOR PHASE I – DESIGN AND PHASE II – FABRICATION AND INSTALLATION SERVICES OF THE ARTWORK PROJECT FOR THE JOSE MARTI MIDRISE HOUSING DEVELOPMENT PROJECT (FROM MIAMI-DADE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT AND RELATED URBAN PUBLIC ART FUNDS)

Recommendation

It is recommended that the Art in Public Places Trust approve a Professional Artist Services Agreement in substantially the form attached with Jacoub Reyes in the fixed fee amount of \$40,000.00 for Phase I-Design and Phase II – Fabrication and Installation Services for the artwork project at the Jose Martin Midrise Housing Development.

Background

A meeting of the Professional Advisory Committee (PAC) was held on March 26, 2026 to review design proposals from a group of seven (7) artists shortlisted from a Regional Call to Artists for multiple public art opportunities for the new housing development at the former site of the Jose Marti public housing community. This public-private partnership between the Miami-Dade Department of Housing and Community Development and Related Urban Group comprise two (2) separate sites and facilities. The first build known as the Jose Marti Gardens (rebranded as Brisas del Sol II) is a 3-story garden-style building with 36 units and the second build, Jose Marti Midrise (rebranded as Brisas del Sol I), is an 8-story mid-rise building with 110 affordable units and community amenities. The call envisioned commissioning public art inspired by the works of seminal Spanish-Cuban author and activist José Martí and his poem “Guantanamera” famously interpreted by renowned singer Celia Cruz

The PAC unanimously recommended commissioning South Florida-based artist Jacoub Reyes to activate the mail room area with artworks exploring themes of individual ancestral cultural heritage and metaphorical explorations of the complex internal emotions of the diasporic experience. Reyes was also recommended to create an original work including a site-specific laser cut polycarbonate installation of a boat reminiscent of improvised sailing vessels used by Caribbean migrants, as well as a series of framed screen prints “Animals”, each 24 x 36 inches depicting familiar domestic and wild animals of the region and agricultural machinery, and the acquisition of framed screen prints from the artist’s series Taino Vessels.

APP staff recommends the approval of Trust Resolution No. APPT 26-18 authorizing a Professional Artist Services agreement in substantially the form attached with Jacoub Reyes in the fixed amount of \$40,000.00 for Phase I-Design and Phase II- Fabrication and Installation Services of the artwork project for the Jose Marti Midrise (Brisas del Sol I) public housing development.
