For a combined total expenditure amount not-to-exceed \$60,000.00 for the Civil and Probate Courthouse project.

Background

A meeting of the Professional Advisory Committee (PAC) convened on August 19, 2022 with the purpose of reviewing artist qualifications for the new Miami-Dade County Civil and Probate Courthouse. This public-private development in Miami's downtown will serve the Civil and Probate Divisions of the Eleventh Judicial Circuit of Florida, the Clerk of Courts and other related court partners including administrative services, court-related programs, court support functions, and facility management services. The new courthouse will functionally replace the existing iconic Miami-Dade County Courthouse which has been in service since the 1920s. The project includes twenty-four (24) floors, forty-six (46) finished jury courtrooms and one (1) additional shell space for an additional four (4) jury courtrooms including fifty-nine (59) secure parking spaces. The courthouse is designed to be a significant landmark.

The opportunities for public art, as expressed in the Call to Artists, include large-scale site-specific artworks for the lobby in the form of durable wall applications and suspended sculpture, two-dimensional artworks to be featured within the main elevator lobby, typical waiting rooms, 12th floor training room, and ceremonial courtroom, artist-designed terrazzo flooring in targeted areas throughout various areas of the facility, including the security screening area, main elevator lobby, 4th floor café, ceremonial courtroom and jury pool holding room. Exterior opportunities include exterior screening system and applied artworks to conceal a utility area and ADA access ramp. Lastly, it is envisioned that an acquisition fund for two dimensional artworks will create the opportunity to purchase existing original works of art for installation within conference room, department lobbies, and

public corridors. The intent is to create a unique Miami-Dade County Civil and Probate Courthouse Artbank Collection.

After review and discussion of the three hundred and twenty (320) artists who submitted qualifications from a national Call to Artists, the PAC unanimously recommended the following twenty-four (24) artists to create full proposals for site-specific commissions:
