Background

A meeting of the Professional Advisory Committee (PAC) convened on September 21, 2023 with the purpose of reviewing artist qualifications for an Invitational Call to Artist for the Phase II project at the Quail Roost Transit Village, a multiphase development by Atlantic Pacific Communities in partnership with Miami-Dade County Department of Transportation and Public Works (DTPW). This second phase of the master development includes the building of 124 elderly affordable housing units in one, 10-story building, with common area amenity space and commercial space on the ground floor. With an artwork commissioning budget of \$245,000, opportunities for public art include but are not limited to enhancements to an exterior colonnade and applied artworks for shared interior areas such as lobbies and multipurpose rooms.

After reviewing the credentials of a selected group of regional artists previously shortlisted by the PAC for two (2) other Call to Artists for similar projects by the same developer, the PAC unanimously recommended inviting the following seven (7) artists to propose for this project:
