Subject:	Report Outlining the Costs Associated with the Surfside Tragedy – Directive No. 211658

On July 8, 2021, the Board of County Commissioners (Board) held a meeting to discuss the Surfside Tragedy. This report is being provided in response to Commissioner Rebecca Sosa's request to outline the costs associated with the County's response and efforts associated with this unfortunate event.

Background

The Champlain Towers South located in the Town of Surfside collapsed in the early hours of June 24, 2021, tragically claiming the lives of 98 persons who inhabited the building. Miami-Dade County engaged in critical search and rescue efforts through Miami-Dade Fire Rescue's Urban Search and Rescue (USAR) Team and Miami-Dade Police Department, who deployed its officers as well as those from partnering municipalities, including Broward Sheriff's Office, City of Coral Gables, City of Hallandale, City of Homestead, City of Miami, City of Miami Beach, City of North Miami, and Town of Medley to the collapse site to assist with incident and perimeter security as well crowd and traffic control. They were joined by thirteen additional County Departments that provided critical support to incident operations and response, including assistance to survivors and families devastated by this unprecedented tragedy.

On the eve of June 24, 2021, Miami-Dade County declared a local emergency with Governor Ron DeSantis following suit soon thereafter. The collective actions of the County and State paved the way for approval of a Federal Emergency Declaration, number FL-3560-EM, from the Federal Emergency Management Agency (FEMA). The declaration was vital in providing the County the opportunity to receive support for eligible expenditures directly related to the Surfside collapse. The Declaration authorized assistance for emergency measures, authorized under Title V of the Stafford Act, to save lives and to protect property and public health and safety, or to lessen or avert the threat of a catastrophe at Surfside and included activation of FEMA's Individuals and Households Program and assistance for debris removal and emergency protective measures (Categories A and B), including direct federal assistance, under the Public Assistance (PA) program.

In addition, the declaration brough forth access to and collaboration with a cadre of national experts from the Army Corps of Engineers and the National Institute of Standards and Technology (NIST) that continue to provide invaluable expertise in managing the structural integrity of the collapse site. FEMA, through its local, regional, and national offices, and the Florida Division of Emergency Management (FDEM) maintain active involvement in all aspects of the emergency's operations and continue to provide technical assistance and guidance as needed by the County. The outpouring of support from this incredible team of professionals has been invaluable and deeply appreciated.

We were also deeply moved by President Joe Biden's involvement and attentiveness in providing support and necessary resources to assist with all phases of this tragedy. On July 1, 2021, President Biden visited the incident site to personally pay his respects and sympathies to grieving families and survivors and to encourage the extraordinary efforts of our first responders who worked tirelessly round the clock until every victim was identified. To provide the County the maximum financial support possible to save lives and recover loved ones, President Biden waived the usual match requirement associated with the

PA program and pledged to provide 100 percent funding for the search and rescue efforts that spanned the first thirty days of the tragedy through July 23, 2021. To assist the County in drawing cash to offset expenses, an expedited project was submitted to FEMA on July 23, 2021, for \$28.2 million which allowed the County to receive a 50% payment of \$14.1 million that was received on September 7, 2021. In accordance with FEMA's Public Assistance Program and Policy Guide (PAPPG), the County was required to submit documentation related to the expedited project within 90 days of the Recovery Scoping Meeting or within 90 days of the work completion date, whichever is later. FEMA makes its eligibility determination based on the documentation received within the 90-day deadline. The 90-day deadline was on October 26, 2021, and the County successfully submitted payroll records, timesheets, invoices, and receipts for over \$26.2 million in costs, as detailed in the enclosed attachment (Attachment A). Upon completion of FEMA's review, the County will be able to submit reimbursement requests to FDEM, who is FEMA's grantee for the Surfside emergency, to draw down the \$12.1 million balance of the cost.

In addition to the initial 30 days project, there are twelve (12) additional projects in the damage inventory mutually approved by the County and FEMA covering all costs of the emergency through the eventual disposal of the collapse's debris. These projects have a combined estimated cost of \$31.7 million of which FEMA will cover 75 percent. The remaining 25 percent, totaling \$7.9 million will be evenly divided by the County and FDEM. This match amount will also be reduced by the value of donations received for the event, which will be quantified prior to close out of the emergency (Attachment A-1).

A completed after-action report will be forthcoming shortly.
