Subject:	August 23, 2022 Primary Election Pre-Election Report

In accordance with Section 12-1 of the Code of Miami-Dade County, this report includes information regarding anticipated voter turnout, utilization of the three voting methods (vote by mail, early voting, and election day), a summary of equipment and personnel, and other relevant topics for the August 23, 2022 Primary Election.

Closed Primary and Other Ballot Content

This election will contain both partisan and nonpartisan races. The Elections Department (Department) will ensure this is a key message, so all voters regardless of party affiliation know to participate in this important election.

For partisan primary races, Florida law permits only voters who are registered members of a political party to vote for their respective party's candidates. This is referred to as a "closed primary." Depending on where the voter resides, registered Republicans and Democrats may vote in federal and state offices. The Department is waiting for the certified list of races and gualified candidate information from the Florida Division of Elections. As soon as this information is received, ballot preparation can commence, and the sample ballot can be made available to voters.

All voters countywide, regardless of party affiliation, are eligible to vote on these non-partisan judicial offices:

- Circuit Court Judge Group 3
- Circuit Court Judge Group 20
- Circuit Court Judge Group 34
- Circuit Court Judge Group 52

- County Court Judge Group 5
- County Court Judge Group 19
- County Court Judge Group 42

Depending on where the voter resides, these non-partisan offices are also on the ballot:

- County Commissioner District 2
- County Commissioner District 6
- County Commissioner District 8
- County Commissioner District 10
- County Commissioner District 12

- School Board District 2 •

In addition, voters in Golden Beach, Key Biscayne, Miami, Miami Beach and Miami Gardens will have additional ballot content.

Redistricting

Delays in the completion of the 2020 Census data, followed by litigation of the State's redistricting process postponed the release of congressional maps. This significantly condensed the timeframe allotted to Supervisors of Elections throughout the State to make the affected boundary changes in the voter registration and tabulation systems. That said, the Department was able to successfully complete the redrawing of these districts. As a result, voters may have new districts, new elected officials, or simply have a number change in one or more districts.

Through a robust media/advertising campaign, the Department will encourage voters to visit their website (<u>www.miamidade.gov/elections</u>) and review their voter information as soon as possible. Additionally, new voter information cards (cards) are being mailed to all voters. Due to the volume, the Department is in the process of sending the cards in batches by County Commission District. This mail out is expected to conclude in the next couple of weeks. All voters will have their new cards no later than mid-July.

We ask for Commissioners' assistance with voter outreach by encouraging voters to pay close attention to the information on their new card including district assignments; make changes to their record if needed; and go the Department's website to review their sample ballot prior to voting.

Importantly, voters are not being relocated to new Election Day polling locations because of redistricting. While it is a best practice and significantly streamlines election administration to "re-precinct" voters after redistricting, there was not sufficient time to properly educate voters about new locations, so this process is being reserved for 2023. This resulted in split-precincts being created. There are now 1,044 precincts countywide.

After the 2022 cycle, the Department will conduct a countywide review of districts, precincts, and polling locations. This will come before the Board of County Commissioners for approval.

Anticipated Voter Turnout

Voter participation in Primary Elections varies for midterm election cycles. Per the historical data provided below, voter turnout has been between 14 to 21 percent. The 2020 Primary Election was in a presidential election cycle, therefore not a true comparison to a midterm, but the hope is this heightened voter enthusiasm will continue. As such, the anticipated voter turnout for this election is between 20-25 percent.

Three Ways to Vote

Voter distribution patterns have continued to shift gradually away from Election Day with each cycle as voters become more accustomed to the convenience of Vote by Mail and Election Day. With COVID at its peak during the 2020 election cycle, a historic number of voters voted by mail. This was not surprising since many people felt safer at home. It is going to be interesting to see if this trend holds now that most people are vaccinated against COVID or if there will be a shift back to in-person voting. This makes anticipated utilization harder to predict than usual.

If 2020 trends hold true, more than 78 percent of the County's participating voters are projected to cast their ballot prior to Election Day. Of those voters who participate, we estimate 62 percent will choose to cast their ballot via Vote-by-Mail Ballot, 16 percent during Early Voting, and the remaining 22 percent will opt to vote at their assigned precinct on Election Day.

Vote By Mail

There are currently 398,080 vote by mail (VBM) requests on file. In May, per Resolution R-453-20, the Department mailed a vote-by-mail request form with prepaid postage to households where at least one voter did not have request on file to ensure they are aware of this option, should they elect to do so.

The last day for voters to request a VBM ballot for this election is Saturday, August 13th by 5:00 p.m. VBM ballots will be mailed on July 9th to overseas voters and on July 21st to domestic voters. Per Florida law, the last day for the Department to mail VBM ballots is Monday, August 15th. Completed VBM Ballots must be received no later than 7:00 p.m. on Election Day, August 23rd to be accepted as valid.

The Department will continue to have "Secure Ballot Intake Stations" (formerly known as Secure Drop Boxes) at all Early Voting locations during the days and hours of operation. Voters can also bring their ballots to these locations during business hours and as noted below:

*On Monday, August 22nd and Election Day, August 23rd, these two locations will accept ballots from 7:00 a.m. - 7:00 p.m.

Early Voting

There will be 23 sites located throughout the County. As is customary, Early Voting is available for fourteen (14) days, the maximum allowed by law from August 8th through August 21st. Voters can go to any location that is convenient for them.

- First week of Early Voting will provide early hours (7:00 a.m. 3:00 p.m., Monday Friday)
- Second week of Early Voting will provide later hours (11:00 a.m. 7:00 p.m., Monday Friday)
- Weekend hours will be standard for both weekends (8:00 a.m. 4:00 p.m., Saturday Sunday)

The Ealy Voting schedule is attached (Attachment 1). Wait times for all 23 Early Voting sites will be recorded throughout the duration of Early Voting and posted on the Department's website starting on August 8th. This will help voters make an informed decision as to when and where is most convenient for them.

Election Day

Voters who prefer to wait until Election Day must go to their assigned voting location between 7:00 a.m. and 7:00 p.m. The Department has confirmed all Election Day polling locations. As with every election, there are a limited number of locations that will change due to facility being unavailable to us. These changes are attached (Attachment 2). Voters affected by a change in their Election Day voting location will be notified in several ways:

• Voters assigned to a temporary voting location - one that will only be utilized for this election, will receive an official notice by mail.

- Voters assigned to a new permanent voting location one that will continue to be utilized for all future elections, will receive a letter indicating the new voting location and a new Voter Information Card with the new voting location name and address.
- A list of permanent and temporary voting location changes will be advertised between August 1st through August 5th in English, Spanish and Creole newspapers of mass circulation.
- Signage will be placed outside the previous voting location in areas that can be seen before voters depart their vehicles to further minimize any inconvenience.
- Voters can confirm their current Election Day voting location by calling 311 or accessing their voter information record on the Elections Department website, where a map and photo of their voting location and other pertinent information is available.

Wait Times and Resource Allocations

Lengthy wait times are not anticipated for this election. With 20-25 percent voter turnout where most voters will choose to vote by mail, a proven Early Voting schedule, and technical and operational enhancements implemented in recent years, voters will continue to have a pleasant and convenient inperson experience.

Additionally, ballot length has proven to be an important variable in wait times. Staffing and equipment allocations now take this variable into consideration. For this election, most voters will receive a one-page ballot.

For Early Voting locations, the preliminary allocation is as follows:

- 96 EVIDs: 4 units at 19 locations and 5 units at the 4 historically highest turn out locations, 1 of which serve as backup
- 96 Ballot-on-Demand Printers: 1 per EVID at each location
- 96 DS200 optical scanners: 4 units at 19 locations and 5 units at the 4 historically highest turn out locations, 1 of which serve as backup
- 46 Express Vote (ADA) voting units: 1 assigned and 1 backup at each location
- 550 privacy booths: varies among locations
- 260 poll workers, which equates to 12-15 employees per site
- 12 administrative rovers, runners and technical troubleshooters traversing the County for quick response time

For Election Day locations, the preliminary allocation is as follows:

- 1,200 EVIDs: a minimum of 2, with a third unit at locations with 3,500 or more voters
- 1,200 DS200 optical scanners: a minimum of 2 per location
- 548 Express Votes (ADA) voting units: 1 at each location
- 6,000 privacy booths: varies among locations
- Approximately 5,400 poll workers, which equates to an average of 9 poll workers per voting location, with additional staff at locations that have co-located precincts, split precincts, and/or more than the average numbers of voters assigned to it.
- 90 administrative and technical troubleshooters
- 40 supply trucks traversing the County in order to facilitate the most immediate response time

<u>Outreach</u>

The Department is engaged in a multi-faceted media and advertising campaign to ensure voters are properly educated prior to this election, focusing on key messages through radio, print, and TV news outlets as well as a strong social media presence. Key messages include: registering to vote or making

changes to party affiliation prior to the July 25th deadline, knowing which voting districts you are assigned to; reviewing your sample ballot online prior to voting; and the three ways to vote.

The Department's in-person community outreach efforts have resumed. If a Commissioner or any other group request the presence of the Supervisor of Elections or department outreach staff at their event, they would be glad to assist the community.
