Please note that the column total indicating "Relief to Property Owners" is not indicative of the actual fiscal impact to the Department. To estimate the fiscal impact, the Department must compare the settlement amount offered under Ordinance No. 11-64 to the estimated settlement amount the Department would have offered under its existing settlement policy. This policy provides an overall lien collection rate of approximately 19 percent for residential cases and does not exempt homeowners from paying civil penalties.

The Department will continue to make serious efforts to assist individuals who qualify for the Amnesty.
