- according to the Centers for Disease Control (CDC), stroke was the fifth leading cause of death in the United States in 2021, and a leading cause of serious long-term disability
- critical medical care delivered within the first sixty minutes of the onset of a stroke can mean the difference between life and death and can minimize the long-term negative effects of having a stroke such as changes in cognitive behavior, mental health, and weakness or paralysis
- a mobile stroke unit is a specialized ambulance that is equipped with trained staff, specialized equipment, including Computed Tomography (CT) machines, and medications that are geared to diagnosing strokes, and saving time between contact with initial emergency medical services and potentially lifesaving medical treatment
- there are eleven hospitals designated as Primary Stroke Centers and ten designated as Comprehensive Stroke Centers in Miami-Dade County
- reso directs the County Mayor or County Mayor's designee to develop a plan for the implementation of a two-year Mobile Stroke Unit Pilot Program (the "Pilot Program") within the Miami-Dade Fire Rescue Department ("MDFR")
