The report recommends removing the 15% affordable housing requirement for expedited review, standardizing reporting methods, completing the transition to a digital permitting system, and enhancing applicant guidance. It also suggests expanding consultant assistance for water and sewer permitting to improve efficiency and transparency in the process.

The report suggests moving forward with JTCHS for the lease and development, highlighting obstacles to leasing to DOH.

The report also recommends monitoring the impact of this change every three years. It addresses the compatibility of workforce housing with single-family neighborhoods and suggests developing thematic or historic zoning standards to preserve neighborhood character. The report calls for the annual update of MSA figures for calculating payments and emphasizes the need for more incentives to build homes for households earning below 80% of Area Median Income (AMI). Finally, it advises ongoing monitoring of new developments for neighborhood compatibility and zoning updates as needed.
