This report outlines key findings and recommendations regarding the County's management of OSTDSs. In 2023 and 2024, the County approved 672 and 709 new OSTDS systems, respectively, focusing on performance-based treatment systems (PBTSs) that provide enhanced treatment of wastewater pollutants. The report highlights a significant reduction in contaminants, such as a 96% reduction in CBOD and a 70% reduction in total nitrogen (TN), due to the use of PBTSs. Additionally, it addresses the ongoing challenge of tracking decommissioned systems and the need for more accurate data collection.

The report advocates for improvements in tracking decommissioned systems, which are currently reported through the Florida Department of Health's abandonment permits but are not fully captured by the County's system. The County has developed an online portal to improve registration accuracy and tracking of existing systems.

This ordinance amends Section 33-333 of the Miami-Dade County Code to allow stand-alone emergency rooms and urgent care facilities within the Critical Approach Zone (CAZ) around Miami-Dade airports, where such uses were previously prohibited. This change aims to provide flexibility for these facilities to be established without requiring a variance, meeting the community's need for additional emergency care options near airports.

Section 33-333 of the Miami-Dade County Code establishes land use compatibility and height regulations around airports, including restrictions on certain uses within designated airport zones to ensure safety and operational efficiency. It outlines specific prohibited and permitted land uses in the Critical Approach Zone (CAZ), Runway Protection Zone (RPZ), and Outer Safety Zone (OSZ).

Section 24-43.1 of the Miami-Dade County Code regulates liquid waste disposal, potable water supply systems, and sewage flow calculations to safeguard public health and manage wastewater and water supply standards. It includes provisions for determining sewage flow, loading requirements, and wellfield protection, as well as specific exclusions and exceptions for certain structures.
