STATUS REPORT ON THE IMPLEMENTATION OF THE REVISED BETTER BUS NETWORK AND IMPLEMENTATION OF A PLAN TO ELIMINATE OVERCROWDING ON METROBUS 836 EXPRESS – DIRECTIVE NO. 240521 AND DIRECTIVE NO. 240824

This report provides a status update on the implementation of the Better Bus Network (BBN) in Miami-Dade County and a plan to address overcrowding on Metrobus Route 836 Express. The BBN, launched in November 2023, was a major redesign of the county's bus network to improve reliability, efficiency, and accessibility. Since implementation, ridership has increased, on-time performance has improved, and service productivity has risen by 14%. The number of high-frequency routes has expanded from 5 to 19, weekend service has been enhanced, and route alignments have been simplified to facilitate transfers and reduce travel times. Additionally, new initiatives such as MetroConnect on-demand transit, the MetroLink fixed-route program, and a temporary Uber voucher program have been introduced to address service gaps.

Regarding Route 836 Express, overcrowding was primarily due to missed trips caused by operational issues, leading to increased passenger loads. However, after corrective actions, data indicates that overcrowding is no longer a persistent problem. The report also highlights community engagement efforts, ridership feedback, and transit service adjustments made since BBN's launch. Financially, the network redesign has led to a 27% decrease in subsidy per passenger, making the system more cost-efficient. The administration continues to monitor route performance, make schedule adjustments, and engage with municipalities to optimize local transit options.

PROGRESS REPORT ON THE IMPLEMENTATION OF THE DEVELOPMENT REQUIRED
INFRASTRUCTURE POLICY (DRIP) CRITERIA -- DIRECTIVE NO. 241791

This report on the Development Required Infrastructure Policy (DRIP) was established by Resolution No. R-821-24 will address water and sewer infrastructure needs in rapidly developing areas while streamlining processes for new developments. The Miami-Dade Water and Sewer Department (WASD) has identified five high-priority areas—Wynwood, Midtown, Edgewater, Brickell, and Downtown—where existing infrastructure is insufficient. Additional areas will be prioritized annually using a "heat map" tracking development trends. To expedite implementation, WASD is using existing Professional Services Agreements (PSAs) for design work and aims to secure new PSAs within 12 months. A streamlined permitting process will be coordinated with the Regulatory Economic Resources Department (RER).

The funding model includes renewal and replacement funds for in-kind replacements and plant expansion funds for added capacity. Developers will contribute through construction connection charges based on infrastructure improvements. DRIP projects will be tracked using the e-Builder system for efficiency. As of this report, three developments in the prioritized areas have expressed interest, with preliminary meetings completed and projects ready for implementation. WASD continues to work with the Department of Transportation and Public Works (DTPW), RER, and municipalities to refine prioritization efforts and expand sewer services to additional areas, such as Little River.

REPORT REGARDING PRIVATE AMBULANCE RATES – DIRECTIVE NO. 220746

This report responds to Directive No. 220746 and Resolution No. R-434-22, which requires an annual review of private ambulance rates in Miami-Dade County. The Department of Transportation and Public Works (DTPW) analyzed the Consumer Price Index (CPI) for the Miami-Fort Lauderdale-West Palm Beach market, which increased by 2.67% from October 2023 to October 2024. If private ambulance rates were adjusted by this percentage, they would remain competitive with Miami-Dade Fire Rescue (MDFR) rates for most services but exceed MDFR rates for Specialty Care Transport and Oxygen services. However, DTPW does not recommend a rate increase this year due to administrative inefficiencies, feedback from private providers preferring stability, and the minimal impact on individual consumers, as most ambulance services are covered by Medicare, Medicaid, or private insurance. The report also notes that MDFR has chosen to keep its rates unchanged for the year.

REPORT EVALUATING THE FEASIBILITY OF INSTALLING AND MAINTAINING FLORIDA FRIENDLY LANDSCAPING ON CERTAIN COUNTY-OWNED OR OPERATED PROPERTIES - DIRECTIVE NO. 231202

This report responds to Resolution No. R-784-23, which directed the Miami-Dade County Mayor to evaluate the feasibility of implementing Florida Friendly Landscaping (FFL) on County-owned and operated properties. The initiative aims to replace non-native plants with Florida native species, reduce water consumption, and integrate sustainable landscaping into County projects. Several County departments have collaborated on this effort: the People and Internal Operations Department (PIOD) has assessed existing sites and initiated a pilot project at the Coral Gables Courthouse; the Department of Transportation and Public Works (DTPW) has identified medians and road shoulders for FFL implementation while ensuring safety compliance; and the Strategic Procurement Department (SPD) has updated procurement requirements to mandate FFL provisions in new projects. Additionally, the Parks, Recreation, and Open Spaces Department (PROS) has committed to planting native and FFL-compliant materials in County parks, while the Office of Management and Budget (OMB) is exploring funding sources for implementation and public outreach.

The report states that funding for FFL outreach and education is not included in the FY 2024-25 Adopted Budget, but tree canopy enhancement funds will be used for public education efforts. The County will continue refining the FFL strategy and report progress to the Board.

The Citizens' Right-to-Know Act Annual Report for Calendar Year 2024 provides an overview of the Miami-Dade Corrections and Rehabilitation Department (MDCR) Pretrial Services Program. The report states that 5,800 defendants were released into the program, with 8% failing to appear for court hearings and 9% being arrested for new offenses while in the program. It details the program's funding, which comes entirely from the Miami-Dade County General Fund. The report includes statistics on defendants assessed for pretrial release, recommendations made, and the number of individuals deemed indigent by the court.

The Chairperson of the Board of County Commissioners will determine whether the Office of Community Advocacy undergoes an audit, while the Mayor or their

designee will oversee audits for other County boards and their administrative offices. If audits reveal deficiencies, the Chairperson or Mayor may take corrective actions, including placing offices under management watch, assigning additional staffing, and requiring periodic compliance reports to the Board of County Commissioners. If an office is placed on management watch, the Mayor must provide a written report to the Board within 30 days of the action.

This ordinance amends the Miami-Dade County Code to authorize the West Perrine Community Redevelopment Agency (CRA) to hire its own staff, including technical experts, agents, and employees, as well as retain its own legal counsel and legal staff. Currently, the Mayor's Office and the Office of the County Attorney are required to provide these services, but this amendment removes that requirement, allowing the Agency to operate with more autonomy. The Office of the County Attorney will serve as interim legal counsel until the Agency secures its own representation. Florida law (F.S. 163.356) permits CRAs to hire their own employees and legal counsel, and other CRAs in Miami-Dade, such as North Miami CRA and Southeast Overtown/Park West CRA, already do so. The amendment also allows, but does not require, the Mayor or designee to provide support services at the Agency's sole cost.

This ordinance amends the Miami-Dade County Employee Protection Ordinance to extend

whistleblower protections to County employees who report violations or suspected violations of local ethics rules under the jurisdiction of the Miami-Dade County Commission on Ethics and Public Trust.
