This report is in response to Ordinance No. 23-28. It identifies all awards exceeding \$1,000,000 made under prequalification pools between June 1, 2023, and May 31, 2024. The purpose of the report is to assist the Board in evaluating whether the current \$5,000,000 threshold for awards subject to Board ratification should be lowered. The report notes that Ordinance No. 24-122, adopted on November 6, 2024, increased the County Mayor's delegated authority for awarding and rejecting competitive contracts from \$1,000,000 to \$5,000,000. To enhance transparency, the Strategic Procurement Department (SPD) created a real-time Pools Dashboard and extracted data from INFORMS, the County's unified bidding platform. During the reporting period, 5,189 spot markets were advertised, resulting in 5,704 awards. Of these, 25 awards ranged from \$1,000,000 to \$5,000,000, and two awards exceeded \$5,000,000. Twelve of the 27 total awards over \$1,000,000 were administered by SPD staff on behalf of departments. The Administration recommends that the \$5,000,000 threshold remain unchanged to align with the recently expanded delegated procurement authority under Ordinance No. 24-122.

The report lists numerous contracts awarded in 2024 and early 2025 for civil engineering, construction, design-build services, maintenance, and development leases, totaling hundreds of millions in investments. Additionally, it outlines federal and state grants awarded, totaling millions in funding for various projects, and includes future federal and state grant applications for fiscal year 2025. The financial summary includes cumulative expenditure tracking for major projects and highlights differences from the previous month's report.

This report is in response to Resolution No. R-319-24 and provides an overview of the 2024 Miami-Dade County Summer Youth Internship Program (SYIP). The program received a total of \$3.75 million in funding—\$1.25 million from the County's general fund and \$2.5 million from The Children's Trust. A total of 3,193 students enrolled, with 3,187 successfully completing the program and earning high school credit. Among them, 482 received dual enrollment credit through Miami Dade College. Of those who completed the program, 73% participated in on-site internships, 22.5% had hybrid experiences, and 4.5% were fully remote. Students from 93 schools participated, including 29 public charter schools, with 164 charter students completing the program. Additionally, 68% of participants qualified as economically disadvantaged and 39% were enrolled in Exceptional Student Education. The report includes a breakdown of participation by County Commission District and highlights outreach efforts to employers, students, and families. It also notes that planning and outreach for increased charter school participation in the 2025 program are already underway.

This report is in response to Resolution No. R-698-24 and outlines Miami-Dade County's current efforts to recruit and hire veterans from 2022 to the present. The County gives preference to eligible veterans and their spouses in the open-competitive recruitment process in accordance with federal and state law. Veterans' preference is extended to individuals who served during a period of war, those with a service-connected disability, spouses of veterans unable to work due to total and permanent service-connected disabilities, and unremarried widows or widowers of veterans who died from service-connected disabilities. Outreach initiatives include strategic

partnerships with the U.S. Army's Partnership for Your Success (PAYS) Program and Veterans Florida through the Department of Defense SkillBridge program to promote employment opportunities for transitioning service members. The County also participates in events aimed at recruiting veterans, including the Veteran Stand Down event hosted by Chairman Anthony Rodriguez in November 2024.

This report is in response to Directive No. 231908 and details Miami-Dade County's response to illicit discharges affecting Biscayne Bay during 2023 and 2024. The Department of Regulatory and Economic Resources, Division of Environmental Resources Management (RER-DERM), conducted inspections that led to Pollution Prevention Field Notices issued to two construction sites for inadequate stormwater pollution controls. The City of Miami also issued a Notice of Violation. A third inspection revealed a vacuum truck, under a City contract, discharging stormwater runoff in violation of County Code, leading to a criminal investigation by the Illegal Dumping Unit. The report outlines RER-DERM's implementation of annual "Hot Spot" inspections to identify and monitor high-risk areas for potential pollution, especially during the rainy season.
