Disclaimer: State Legislation May Override Local Actions on Water Fluoridation.

On April 29, 2025, the Florida Legislature passed Senate Bill 700 (SB 700), also known as the Florida Farm Bill. This legislation includes provisions that would prohibit local governments from adding health-related additives, such as fluoride, to public drinking water. As of May 2, 2025, the bill is awaiting the Governor's signature. If signed into law, it would take effect on July 1, 2025, and would preempt local authority on this matter. Therefore, any local action taken by the Board of County Commissioners related to water fluoridation may be superseded by state law if SB 700 is enacted.

This report from the Department of Transportation and Public Works (DTPW) outlines the service adjustments to Miami-Dade County transit services scheduled for the March 31, 2025 lineup. No fare changes are included. Bus changes include minor route modifications for Routes 9, 17, 21, 101, and 104, trip pattern changes to enhance end-of-line service on Routes 17, 24, and 100, and schedule improvements for 12 routes to reflect traffic conditions or improve reliability. Eight routes will have frequency/span changes based on ridership, and 19 routes will have one or more first or last trips discontinued due to low ridership. The contracted Killian Parkway and Opa-Locka MetroLink demonstration services will be discontinued, the former being replaced by realigned Route 104. No rail service changes will be made. The net fiscal impact of these changes is an annual savings of approximately \$5.2 million.

This report, submitted in response to Resolution No. R-788-24, provides the first quarterly update on the execution and expenditure of State of Florida funds awarded to Miami-Dade County during the FY 2024-25 legislative session. The County received legislative appropriations totaling \$11,084,563 for 11 approved projects out of the 12 submitted, with required County matching funds totaling \$12,152,688. These projects span six departments and address critical needs, including improvements to Biscayne Bay infrastructure, support for homelessness initiatives, fire rescue services and equipment, public transportation, and animal services.

This report, prepared in response to Resolution No. R-895-23, presents findings on the status of registration by condominium, cooperative, and homeowners' associations under Miami-Dade County's Community Association Registry, as required by Chapter 17D of the County Code. As of March 12, 2025, 3,939 associations have registered, with 1,598 working to renew their 2025 registration and 151 in the process of registering for the first time. This results in an approximate 84% compliance rate, rising to 87% when including in-progress applications

Public education efforts have included emails, physical mailings, webinars, and community meetings. The County has implemented an enforcement process through Chapter 8CC, with penalties for non-compliance ranging from \$200 to \$1,000.

To further assist residents, the County created a Condo Assistance and Compliance Manager role to serve as the point of contact for condominium-related issues, including building recertifications and code enforcement. The report concludes that the associated measures to improve registration compliance and public awareness can be absorbed within existing departmental budgets.

This report, issued in response to Resolution No. R-886-24, provides an assessment and recommendations regarding suitable areas in Biscayne Bay for vessel anchoring and potential future mooring fields. The report outlines regulatory considerations, including distinctions between anchoring and mooring, and details state and county-level permitting requirements. The report emphasizes that while anchoring is lightly regulated at the county level, mooring requires a Class I permit and compliance with environmental protections

Recommendations include working with the Parks, Recreation and Open Spaces Department (PROS) to determine the feasibility of expanding County mooring facilities, identifying suitable municipal sites for managed mooring fields, and continuing efforts to establish Anchoring Limitation Areas (ALAs) in appropriate locations. The report concludes that further site-specific analysis is necessary to determine feasibility and funding sources for any proposed expansion.
