Notes:

This report was prepared in response to Resolution No. R-788-24, adopted on September 17, 2024, and provides a second-quarter update on state funding for Miami-Dade County projects approved by the Florida Legislature in 2024. As of April 1, 2025, six projects (Projects 2, 4, 5, 7, 10, and 11) have signed contracts, and about \$491,898 has been spent so far. Three projects (Projects 1, 3, and 9) are still waiting for their grant agreements to be finalized. All projects are on track with their original funding plans.

Four projects (Projects 4, 7, 10, and 11) must be completed by June 30, 2025, to meet state deadlines, which the County will meet. The Miami-Dade Fire Rescue Urban Search and Rescue project (Project 8) was moved to the 2025-26 budget year because the land transfer needed for it is still pending. The Bill Sadowski Park Improvements project (Project 12) was withdrawn from the state program, and Project 6 did not receive any funding.

Overall, out of the 12 projects requesting \$19.1 million, 10 were awarded funding totaling \$5.8 million. The County is required to provide almost \$5 million in matching funds. The report emphasizes that agreements need to be signed quickly so the projects can move forward and meet legislative requirements.

This report responds to Directives Nos. 162394 and 231535 and provides information on the collection of mobility fees, impact fees, and water and sewer connection fees for the fourth quarter of 2024, covering October 1 to December 31, 2024. It includes collections by commission district for educational facilities, fire and emergency medical services, parks, police,

roads, water and sewer connections, and the new mobility fee. During this quarter, the County collected approximately \$4.53 million in educational impact fees, \$2.06 million in fire and EMS impact fees, \$1.54 million in park impact fees, \$443,243 in police impact fees, \$14 million in road impact fees, \$5.09 million in water and sewer connection fees, and \$9.83 million in mobility fees. The new countywide mobility fee replaced the road impact fee and went into effect on December 31, 2023, and collections are expected to increase as older permits close out. The report notes that the amounts listed are gross collections and do not reflect any refunds, and that these funds must be spent within the same program district where they were collected. Additionally, educational facilities impact fees are sent to the Miami-Dade County School Board each quarter.

This report is in response to Resolution No. R-333-24 and it provides a quarterly update on state and federal funding secured by Miami-Dade County since 2020. It includes awarded grants, pass-through grants, required matching funds, and pending applications. From January 1, 2020, through December 31, 2024, the County has been awarded approximately \$6.14 billion in federal funding and \$712 million in state funding. For the first quarter of FY 2024-25 (October 1 to December 31, 2024), the County received approximately \$9.2 million in federal grants and \$18.57 million in state grants. As of December 31, 2024, federal grant applications totaling \$400.9 million and state applications totaling \$290.9 million remain pending. The data in the report is compiled from the Grants Information Management System (GIMS) maintained by the Office of Management and Budget. The report also reflects changes following the establishment of the Miami-Dade Sheriff's Office (MDSO) effective January 7, 2025, including transitioning management of relevant grants from the Police Department to OMB. The report is organized by granting agency and includes award amounts, matching fund information, responsible County departments, project descriptions, and start dates.

This report is in response to Resolution No. R-333-24 and it outlines the federal and state funding awarded to Miami-Dade County for the second quarter of Fiscal Year 2024-25 (January 1 to March 31, 2025). During this period, the County secured approximately \$64.8 million in federal grants and \$171,787 in state grants. Since January 1, 2020, the County has cumulatively received

about \$6.2 billion in federal and \$712 million in state funding. Additionally, as of March 31, 2025, the County has approximately \$438.6 million in pending federal grant applications and about \$139.8 million in pending state applications.

The funding supports a wide range of services and infrastructure, including programs for seniors, HIV/AIDS services, housing for the homeless, transportation upgrades, environmental protection, public safety, and emergency preparedness. The report reflects all grants awarded or applied for within the specified quarter, including pass-through grants and required matching funds, as entered into the County's Grants Information Management System (GIMS).

Notes:

This ordinance approves the annual solid waste collection fees for residential customers in unincorporated Miami-Dade County and areas within the Solid Waste Collection Service Area. It allows the County to place these fees as non-ad valorem assessments on property tax bills for FY 2025-26 to fund garbage, trash, and recycling services.

The Department of Solid Waste Management presented three options for the Board to consider:

Option 1 (Administration Recommended): Increase the fee by 2%, which is about \$14 more per household per year (from \$697 to \$711), or about \$0.14 more per pickup. This option will generate an additional \$4.6 million and keep reserves healthy, helping avoid larger increases in the future.

Option 2: Increase the fee by 1%, which is about \$7 more per household per year (from \$697 to \$704), or about \$0.07 more per pickup. This will generate about \$2.4 million but may still require larger increases next year.

Option 3: Keep the fee the same at \$697 per household. While this option avoids an increase this year, it puts the service fund at risk of running low and could lead to bigger increases or service disruptions next year, especially if there is an emergency like a hurricane.

These fees fund twice-weekly garbage pickup, two bulky waste pickups per year, recycling every other week, and access to neighborhood trash and recycling centers. The ordinance confirms that these fees will be collected like property taxes and will become liens on the property if unpaid. Property owners will receive notice before adoption and have the right to object at public hearings. The Administration recommends Option 1 to maintain reliable services and long-term financial stability.
