This report provides an update on the implementation of Miami-Dade County Resolution R-948-24, which directed the elimination of pre-employment physical and medical examinations for certain County job positions. The People and Internal Operations Department (PIOD) amended County Procedure No. 486 (Physical Examinations) to remove these requirements for positions that are primarily administrative, professional, or clerical, while maintaining examinations, including drug and alcohol screening, for safety-sensitive, high/special risk, DOT-related, and physically demanding jobs. PIOD will submit an agenda item to rescind Administrative Order 7-27 and approve Implementing Order 7-27 to align with this policy change, which aims to reduce onboarding time for new hires. The intergovernmental agreement with Jackson Health System was reviewed with no contractual conflicts, and the Miami-Dade County Careers website has been updated to reflect these changes.

COUNTY FUNDED AFFORDABLE HOUSING ACTIVITIES REPORT – FY2024 FOURTH QUARTER Sponsor(s): Mayor

This report provides the fourth quarter FY2024 (July 1 – September 30, 2024) update on Miami-Dade County's affordable housing activities funded by Housing and Community Development (HCD). The total awarded funds increased by \$7,648,974 from the previous quarter, with notable new allocations including \$1.5 million from the Capital Funds Program and \$5,398,974 in Surtax funds, supporting four new projects. During this quarter, the number of open affordable multifamily housing projects rose from 72 to 76, adding 831 units for a total of 10,501 units, while no projects were completed. Additionally, closed homeownership and condominium special assessment program loans increased from 195 (\$7.6 million funded) to 288 (\$10.2 million funded) this quarter.

Notes:

This report provides a review of Miami-Dade County's solid waste management strategies, as

directed by multiple Board resolutions. Key findings include that no waste-to-energy (WTE) respondents offered specific siting details or their own properties, though several suggested public-private partnerships (P3s) with private financing models and County property leases. The administration recommends continuing long-hauling waste using current contracted capacity while exploring an out-of-county landfill and implementing Zero Waste Master Plan initiatives. The report also summarizes market research showing WTE facilities would cost \$1.5B-\$1.9B over 7-10 years with operating costs of \$45-\$75 per ton, while landfill optimization remains the most financially feasible near-term solution, maintaining current disposal rates at \$78.50 per ton versus future third-party disposal costs of \$97.79 per ton if expansions are not pursued.

The report recommends pursuing landfill optimizations at North Dade and South Dade Landfills for additional life and revenue, continuing stakeholder input for the Zero Waste Master Plan due by 2026, and evaluating multiple waste diversion and recycling programs.

This report provides the first quarter FY2025 (October 1, 2024 – December 31, 2024) update on Miami-Dade County's affordable housing activities funded by Housing and Community Development (HCD). Total awarded funds decreased by \$12,091,813.36 from the previous quarter, primarily due to the completion of two projects: 1535 NW 1st Place and Pinnacle at Tropical Pointe. During this quarter, the number of open affordable multifamily housing projects decreased from 76 to 75, while two projects were completed, adding 225 units for a total of 10,934 units. Closed loans under homeownership programs and the condominium special assessment program increased from 288 (\$7.6 million funded) to 327 (\$11 million funded) this quarter.

a sub-grantee from the USDA's Women, Infant, and Children Community Innovation and Outreach Project through Nicklaus Children's Hospital (NCH) for nutrition education, enrollment services, and implementing the MDxACCESS Health Information Exchange from January 6, 2025, to December 31, 2026. The funding will be used by the Community Action and Human Services Department (CAHSD) to expand nutrition services for Head Start and Early Head Start participants, partner with Fruity Veggie Nutrition, Inc., and create a shared data hub to streamline WIC referrals and enrollment, aiming to close participation gaps for approximately 19,445 unserved eligible women, infants, and children in the County. The item authorizes entering into necessary agreements, applying for future grants for up to 10 years without committing County funds beyond in-kind services, and waives Resolution No. R-130-06 to expedite implementation. NCH will lead the project.

Resolution R-130-06 requires that any contract between Miami-Dade County and third parties must be fully negotiated and signed by all non-County parties before being placed on a Board agenda.

This resolution will approve the Confidential Project Mercurio, a satellite manufacturing company, to participate in the County's Targeted Jobs Incentive Fund (TJIF) program and receive up to \$594,000.00 over 10 years from Countywide General Fund revenues. The company plans to establish a new 90,000-square-foot facility in District 9 and invest \$25 million while creating 235 new high-paying jobs with an average annual salary of \$69,255.00, plus retaining 12 existing jobs. This expansion is projected to generate \$745,911.00 in new property tax revenues for the County and deliver a net fiscal benefit of \$151,911.00. The project must meet all TJIF requirements, including a five-year job creation timeline, hiring Miami-Dade residents where possible, and maintaining those jobs to remain eligible for incentive disbursements.

This ordinance establishes minimum standards for municipal public utilities operating water and sewer services outside their city boundaries within Miami-Dade County. It requires these utilities to comply with Chapter 180, Florida Statutes, and provide the Miami-Dade Water and Sewer

Department with written terms and conditions for service agreements with outside consumers within 30 days of this ordinance's effective date or any future changes. Violations carry a civil penalty of \$500 per violation, and repeated violations within two years may result in the Board considering taking over or regulating the municipal utility under its Home Rule Charter authority. The ordinance becomes effective 10 days after enactment.

Chapter 180 grants municipalities legal authority to build and operate water, sewer, and related utilities, including serving areas outside city limits if they comply with statutory procedures and agreements.

This includes boards with advisory roles, oversight functions, or quasi-judicial duties, such as the Unsafe Structures Board and the Board of Rules and Appeals. The measure reinforces that policymaking authority rests solely with the Board, regardless of previous code provisions or resolutions.
