The Miami-Dade Aviation Department Capital Program Report for June 2025 provides an update on the progress of modernization and improvements at Miami International Airport (MIA) and the County's General Aviation Airports. Key updates include the installation of 33 new passenger boarding bridges out of 95 scheduled by 2030, modernization of 48 out of 207 public restrooms, and upgrades to 616 moving walkways, escalators, and elevators, with over 97% now in operation. Major capital projects include terminal redevelopments, modernization of Concourse F, expansion of the South Terminal, new cargo handling facilities, and a new privately funded airport hotel.

The report also highlights customer service and community initiatives such as the I AM MIA campaign to train more than 37,000 airport employees and youth programs like aviation-focused events with local Girl Scouts. These efforts aim to improve passenger experience, expand economic opportunities, and prepare the airport to handle future demand of 77 million passengers and 4 million tons of cargo by 2040.

The Miami-Dade Aviation Capital Program Report for July 2025 highlights ongoing projects and improvements at Miami International Airport (MIA) and the County's General Aviation Airports. The report notes major modernization efforts, including upgrades to passenger boarding bridges, restrooms, and moving walkways, with measurable progress such as 97% of conveyances now in service compared to 85% in 2024. Construction is underway on a new access gate to improve safety and efficiency during MIA's transformation, with completion expected in Summer 2026. Large-scale capital projects include the Central Terminal Redevelopment Phase II and the design of a new Concourse K, supported by contracts valued in the hundreds of millions, as well as planned baggage handling system upgrades, re-roofing projects, and additional parking garages.

Federal and state grant funding continues to support these projects, with recent awards exceeding \$15 million from the FAA and \$5.5 million from FDOT. The report underscores MIA's role as a global hub supporting jobs, customer service programs, and events like the Volunteer Ambassador Gala and Co-Motion Annual Event. The combined \$7 billion capital program and \$1.7 billion maintenance plan are designed to replace aging infrastructure, improve customer experience, and prepare the airport to meet projected demand of 77 million passengers and 4 million tons of freight by 2040.

This report provides an update on the County's efforts to obtain elective pay clean energy tax credits through the Inflation Reduction Act of 2022. Following approval of Resolution No. R-639-24 in July 2024, Miami-Dade County successfully claimed tax credits for the 2023 calendar year under the Commercial Clean Vehicles Credit and the Alternative Fuel Vehicle Refueling Property Credit, resulting in a \$3,118,651.06 refund issued by the IRS in

April 2025. These funds were deposited into the County's General Fund. For the 2024 tax year, staff projects an additional \$700,000 in eligible tax credits.

This Annual Report on Non-Ad Valorem Assessments provides the Board of County Commissioners with a complete list of all County non-ad valorem assessment rates approved for Fiscal Year 2024–25 and the proposed rates for Fiscal Year 2025–26. The report details the services funded by these assessments, including residential waste collection fees and street lighting services across numerous special taxing districts. For example, the household residential waste collection fee is proposed to in FY 2025–26, while most street lighting district rates remain unchanged, with only select areas showing rate adjustments up or down.

The report also outlines the schedule for adopting these rates, which includes a first reading before the Board on June 3, 2025, public notices by June 23, 2025, and public hearings beginning July 1, 2025.

This Report on County Employees Contributions to Charitable Organizations Program responds to Resolution No. R-1026-23, which directed the expansion of charitable giving options for County employees. The program increased the number of eligible charitable organizations from one to thirteen, including groups such as 5000 Role Models of Excellence, American Cancer Society, Chapman Partnership, and Goodwill Industries of South Florida. Employees can now contribute to these organizations through payroll deductions in the INFORMS system, supported by a step-by-step guide and a dedicated Employee Giving Program webpage. Outreach efforts included tabling events at the Stephen P. Clark Center, participation in the County's Annual Family Fun Day 5K, newsletters, and collaboration with The Miami Foundation for Give Miami Day.

As of May 7, 2025, total employee contributions reached \$6,026.50. The report also recommends that future eligible organizations provide services across the County, focus on human services, and maintain an annual operating budget of at least \$250,000.

This Report on Automated External Defibrillators (AEDs) and Stop the Bleed (STB) Kits in County Facilities responds to Resolution No. R-884-24, adopted on October 1, 2024, directed an update on the program's status, additional locations for devices, and the fiscal impact. As of 2025, the County has 2,815 AEDs and 433 STB kits installed across facilities. Departments have proposed installing 197 more AEDs and 485 more STB kits at a total of 244 sites, with a projected fiscal impact of \$1,616,782. Departments are also responsible for ensuring training for personnel on device use, placement, and maintenance.

Funding for new devices will come from existing contract allocations, the FY 2024–25 County Budget, and potential grants, with AEDs costing between \$400–\$2,500 each and STB kits ranging from \$50–\$100. Multiple contracts, including Contract No. BW-10125, are in place for purchasing devices, and additional expenditure authority may be required for expansion. Since the program began under Resolution No. R-1210-20 in 2020, the County has added 300 AEDs and 270 STB kits. Training programs are ongoing across departments.

The Seaport Department Quarterly Report of Grant Agreements and Amendments covers the period from April 1, 2025, through June 30, 2025, in response to Resolution No. R-598-21. The report documents the execution of one Florida Department of Transportation (FDOT) grant for the PortMiami North Bulkhead Improvements project, valued at \$640,000, executed on June 16, 2025. This grant supports predevelopment services estimated at \$30 million, including engineering analysis, site assessments, and planning, with PortMiami responsible for a 25% matching contribution of \$213,333, which is included in the Seaport's adopted budget and multi-year capital plan.

The First Quarter 2025 Report on the Collection of Mobility Fees, Impact Fees, and Water and Sewer Connection Fees provides the amounts collected by the Commissioner's Districts between January 1 and March 31, 2025. The report shows collections of \$9.19 million for educational facilities impact fees, \$1.97 million for fire and emergency medical services impact fees, \$1.17 million for park impact fees, \$395,123 for police impact fees, \$16.07 million for road impact fees, \$5.76 million for water and sewer connection fees, and \$20.3 million for mobility fees. It also notes that the mobility fee program, created by Ordinance No. 23-68 and effective December 31, 2023, is gradually replacing the road impact fee, but collections of road impact fees will continue until previously assessed permits are paid or expire.

The report clarifies that fee collections reflect gross payments (not including refunds), and funds must be spent within the same program district where they were collected. It also states that revenues from educational facilities impact fees are transmitted quarterly to the Miami-Dade County School Board

The First Quarter Budget Report for Fiscal Year 2024–25 provides a department-bydepartment breakdown of budgeted revenues, expenditures, authorized positions, and actual data for the period of October 1, 2024, through December 31, 2024. The report shows that revenues such as carryover, proprietary fees, federal and state reimbursements, and interagency transfers are not evenly collected throughout the year, with many general fund transfers scheduled for the fourth quarter. Several departments, including Corrections and Rehabilitation, Fire Rescue, Transportation and Public Works, Solid Waste, Water and Sewer, and Public Housing and Community Development, reported higher-than-anticipated expenditures, largely tied to overtime, capital costs, or timing of reimbursements.

The Second Quarter Budget Report for FY 2024–25 provides department-by-department details on revenues, expenditures, authorized positions, and vacancies for the period of January 1 through March 31, 2025. The Mayor's cover memo highlights efforts to streamline budgets, eliminate redundancies, and maximize savings during the current fiscal year. It notes that the Corrections and Rehabilitation Department may require an end-of-year general fund budget amendment due to higher-than-anticipated expenditures, primarily related to overtime costs used to stabilize its workforce following release from federal oversight. The report also shows that while personnel costs in several departments came in lower than budgeted due to attrition (for example, resignation or retirement), expenditures such as contractual services, capital costs, and debt service are unevenly distributed throughout the year, meaning many adjustments are expected in later quarters.
