Notes:

This quarterly report, submitted in response to Resolution No. R-992-24 adopted November 6, 2024, covers the quarter ending March 30, 2025 and documents compliance with IO 8-4 for County-owned properties conveyed or leased with restrictions, including identification of noncompliance, enforcement actions, remedies, and updates. PIOD is monitoring 386 properties (216 deeds and 170 leases); of the deeds, 90 are non-compliant, and of the leases, 16 are noncompliant; HCD identified 183 deeded properties, of which 125 are non-compliant. Enforcement actions taken include delinquent tax notifications, compliance update requests, rental compliance letters, and notices of default, which to date have resulted in the collection of more than \$600,000 in delinquent property taxes; as of September 30, 2025, 1 conveyance is within 30 days of a milestone or potential default, and the report notes reversion/termination actions (PIOD: one property reverted and one lease terminated; HCD: four properties reverted). The report states that ORED (within PIOD) is the lead for centralized real estate management, PCAT is conducting systematic monitoring, the DREAM Work Group (launched February 2025) coordinates long-range planning, a single database for all conveyances and leases will be completed no later than the Quarterly Report ending December 31, 2025, and additional measures include reviews for potential reversion or surplus, development of a public-facing dashboard, and a reinvestment framework and portfolio-wide utilization/condition tracking system.

The Final Program Report, submitted pursuant to Resolution No. R-205-23, documents the 15-month Eviction Diversion Pilot Program (extended to a total of 18 months through September 30,

2024) managed by the Office of Housing Advocacy to provide outreach and free legal assistance to tenants at or below 80% AMI.

The County committed more than \$2.9 million to Legal Services of Greater Miami (LSGMI) and partners and ultimately allocated \$3,159,000.00, including awards of :

- \$321,153 to CABA Pro Bono Legal Services
- \$94,380 to Community Justice Project
- \$384,184 to Miami Workers Center
- \$125,000 to Haitian Lawyers Association
- \$125,000 to the Wilkie D. Ferguson, Jr. Bar Association

A total of \$259,000 was recaptured from the Workforce Housing Incentive Program; partners later leveraged almost \$3 million in additional public and philanthropic grants. Between 2023 and 2024, the Program provided legal assistance in approximately 2,060 eviction cases; 617 families received extended representation, of which 251 evictions were prevented and 296 were delayed, with "almost 90%" of extended-representation cases preventing or delaying judgment. Legal support resulted in over \$3.6 million in total funds avoided or recovered, and a preliminary analysis indicates a 59 percent increase in tenants with legal representation at eviction proceedings compared to 2019. Outreach included door-to-door engagement to 15,000 tenants, 3,000 referrals to LSGMI, education and events in each Commission District serving over 1,000 residents, and legal staff dedicated over 7,000 hours to extended representation. LSGMI handled over 1,400 cases (nearly 30 percent extended representation), CABA assisted nearly 500 cases (33 percent extended), and HLA/WDFJBA handled over 100 cases (21 percent extended).

(24FRAAI001), and Longitude Surveyors, LLC (24LSLLC003) to provide general land and engineering surveying/mapping services during design, construction, and post-construction, including underground utility locating and QA/QC of topographic and as-built surveys. This resolution approves a State-Funded Grant Agreement with FDOT under the County Incentive Grant Program to reimburse Miami-Dade County up to \$2,599,000 for road improvements on SW 127 Avenue from SW 136 Street to SW 128 Street (approximately 0.5 miles) in District 9. The improvements include widening the roadway from two to four lanes and adding a raised landscaped median with irrigation, bike lanes, sidewalks, curb and gutter, stormwater drainage, pavement markings and signage, intersection/signalization upgrades, roadway lighting, permitting, construction administration, geotechnical services, and utility coordination. The total

project construction cost is \$5,198,000, with the County providing the 50% local match of \$2,599,000 from Mobility Impact Fee funding. The Mayor/designee is authorized to execute the agreement and to receive and expend these and any additional funds that may become available. Prior to starting work, the County must enter into this agreement with FDOT, and upon completion, the County will provide maintenance operations within the County right-of-way.

This resolution approves Project Santander to participate in the County's Targeted Jobs Incentive Fund (TJIF) and authorizes the Mayor or designee to execute the agreement and make non-substantive timeline adjustments, with incentive awards not to exceed \$5,000,000 from the Countywide General Fund paid in \$500,000 installments in FY 2027–28, 2028–29, 2029–30, 2030–31, 2031–32, 2032–33, 2033–34, 2034–35, 2035–36, and 2036–37, subject to annual appropriations. The project proposes a 928,000-square-foot facility in District 5 with a \$290,760,000 capital investment, 250 new full-time jobs with an average annual wage of \$115,000 plus \$25,000 in benefits, and retention of 702 existing jobs, with up to 5 years to create the new jobs, a minimum program requirement of at least 10 jobs, and a maximum incentive of \$20,000 per direct job. The item states projected incremental Countywide General Fund property tax revenues of \$9,264,816 over 10 years and projected net new tax revenue of \$4,264,816, with TJIF disbursements over 10 years contingent on verified job creation, capital investment, and tax payments, and with hiring practices to reflect County diversity and a good-faith effort to hire County residents.

The sale is expected to price in November 2025 and close on December 4, 2025, continuing disclosure is due annually by June 1 with audited financials within eight months (or unaudited, followed by audited when available), and a waiver of Resolution R-130-06 is requested to allow post-adoption execution of the Bond Purchase Agreement.
