The report notes that current initiatives include upgrades to terminal facilities, parking structures, and security systems, as well as improvements in cost estimating, scheduling, and project management processes.

REPORT EVALUATING THE FEASIBILITY OF JOB ORDER CONTRACTING FOR COUNTY CONSTRUCTION PROJECTS – DIRECTIVE NO. 241510

Notes:

This report responds to Resolution No. R-883-24 and evaluates whether Job Order Contracting (JOC) is feasible and beneficial for Miami-Dade County construction projects, especially those below the competitive threshold of \$481,867.24. It finds that JOC can speed up project delivery, reduce repetitive bidding, provide standardized pricing, and support participation from Small Business Enterprises for eligible work, but requires upfront investment in catalog development, software, training, and oversight. The report recommends launching a pilot program using an existing competitively awarded JOC contract, developing internal procedures and training, defining eligible project types and thresholds, identifying funding for a small implementation team and license/management fees, monitoring performance, and reporting back to the Board with recommendations on expanding or continuing the program. The report notes that changes from Florida House Bill 705 limit the County's ability to apply local preference programs, making JOC a potentially more viable option under current law. The report states that funding for the pilot implementation team and the license/management fee must still be identified.

This ordinance authorizes Miami-Dade County to issue up to \$600,000,000.00 in short-term Aviation Commercial Paper Notes (CP) at any one time to temporarily fund a portion of the Aviation Department's Capital Improvement Program, with repayment coming from future long-term aviation revenue bonds previously authorized under Ordinance No. 20-61, which approved up to \$5,000,000,000.00 in Aviation Revenue Bonds, of which \$521,910,000.00 has been issued to date. The CP Notes may be issued in one or more series and used to pay or reimburse costs of improvements, pay principal and interest on the Notes, and cover issuance costs, and will be secured solely by aviation revenues and not by ad valorem taxes or the County's general credit. The CP Program continues the County's use of commercial paper first established in 1998 and allows access to short-term interest rates until long-term fixed-rate bonds replace the Notes, with the current program expiring March 18, 2026.

This ordinance creates Section 33-26.1 and amends Sections 33-1 and 33-304.2 of the Miami-Dade County Code to clarify zoning standards and procedures for certified recovery residences. It establishes a process allowing certified recovery residences to request reasonable accommodations from land use regulations and requires applications to include a property folio number, a 7-day review for completeness, and a final decision within 21 days of a completed submission unless an extension is agreed upon. The ordinance also defines "certified recovery residence" in alignment with state law and adds a completeness review period for processing reasonable accommodation requests. This action ensures compliance with Senate Bill 954,

which mandates all local governments adopt such procedures by January 1, 2026, and supports both neighborhood planning and accessibility for residents in recovery.

Recovery Residence is a group living arrangement that provides a peer-supported, alcohol-free, and drug-free environment for individuals recovering from substance use disorders. Under Florida Statutes §397.311, these homes may operate independently or as part of a licensed treatment facility. A certified recovery residence is one that holds a valid state-issued certificate of compliance and is managed by a certified recovery residence administrator, as outlined in § 397.487, Florida Statutes.
