

INTERNET SERVICES AGREEMENT
BETWEEN
LEE COUNTY PROPERTY APPRAISER
AND
LEE COUNTY TAX COLLECTOR

This Agreement, made and entered into this 13th day of April, 2011 ("Agreement"), by and between **Cathy Curtis, Lee County Tax Collector**, ("Tax Collector") a constitutional officer of the State of Florida, whose address is 2480 Thompson Street, Fort Myers, Florida 33901-3074 and **Kenneth M. Wilkinson, Lee County Property Appraiser**, ("Property Appraiser") a constitutional officer of the State of Florida, whose address is 2480 Thompson Street, Fort Myers, Florida 33901-3074

The Tax Collector and Property Appraiser independently contract out for Internet service ("ISP") and in order to increase efficiency and obtain the most competitive pricing available for the services needed, the Tax Collector and the Property Appraiser have concluded that it is in their mutual interest to share costs and resources regarding an ISP.

The parties herein agree that the Tax Collector shall enter into a contract with Level 3 for the provision of Internet service. The Level 3 contract is initially for a 50Mbps circuit for a five (5) year term at \$1,522.03 per month. The parties agree that the Tax Collector shall be reimbursed by the Property Appraiser for the amount agreed upon below.

Based upon a share of bandwidth 30 % for the Tax Collector, 70 % for the Property Appraiser, the Property Appraiser's share is \$ 1,065.61 per month for the five (5) year term.

Payment shall be made to the Tax Collector commencing the first month that the Level 3 contract takes effect. Subsequent payments shall be made no later than the 15th of each month. The Property Appraiser reserves the right to prepay to the Tax Collector all or a portion of their share at any time.

If the Tax Collector or the Property Appraiser determines that this agreement needs to be modified, such modification shall be done in writing and will be entered into without affecting the current contract in place with Level 3. If either party's bandwidth needs exceed what is available, parties by mutual consent may request an upgrade of service with Level 3 with the proportionate share of costs continuing to apply based upon bandwidth.

This agreement shall continue for the duration of the contract with Level 3. If either the Tax Collector or Property Appraiser wishes to cancel this agreement, cancellation shall be done in writing with each party being responsible for the entire balance of their current contract share being due and payable on the termination date. The only exception for cancellation shall be if either the Tax Collector or the Property Appraiser's budget is not funded for this item for a

subsequent fiscal year. The request to cancel due to an unfunded budget shall be made in writing and shall trigger a cancellation of this Agreement and a cancellation of the Level 3 contract.

The Level 3 contract is attached as Exhibit 1 and is incorporated herein and made part of this agreement.



The parties initially agree that Level 3 will connect to a router supplied and maintained by the Tax Collector. From there, the Tax Collector will provide the Property Appraiser with service. The initial Internet connection diagram is attached as Exhibit 2. The parties agree to work together to ensure that each agency has the appropriate access and level of service. This includes redundancy and back up procedures as deemed appropriate by the parties. The technical setup may change by mutual consent of the parties.
